

Resident Gives Back as Tax Center Volunteer

Margine Barrera Sanchez's connection to us is unique – she is both a resident and a volunteer for our biggest community program. As one of our 500 trained and certified CommunityTax Center volunteers, Margine helps low-income families prepare and file their taxes for free.

Margine works full-time as a legal assistant and moved to Austin from Nicaragua three years ago with her daughter Grace. A good friend introduced Margine to Foundation Communities upon her arrival to Texas, and Margine and Grace have lived at our Sierra Vista community ever since.

Volunteering has always been important to Margine. At our tax centers, Margine is able to help families become more financially stable. She also draws parallels between herself and the clients she assists.

“I think many people are like me – they are trying to save money to achieve their goals,” Margine said. “I see myself reflected in the clients.”

Similar to many of the clients she meets with, Margine sends money to family members back home each month. Supporting multiple people on one income is challenging, but Margine said living at Sierra Vista has eased the burden. Her

1-bedroom apartment is affordable, and she is able to take advantage of the free support services offered on-site, including the food pantry, holiday program and health classes.

Margine is also actively working towards her own goals. Buying a house is at the top of her list. She enrolled in our money management class to create a financial plan and she is committed to making this dream a reality for her family.

Margine has worked incredibly hard to get to where she is today. Before moving to Austin, she earned an MBA and spent seven years working at the American embassy in Nicaragua. She left her home country in order to make a better life for herself and her daughter. And there are no signs that she is slowing down any time soon. Her trajectory is inspiring.



Over the next few months, Margine will spend her Saturdays at our Community Tax Centers helping local families take steps on their own paths to success.
