Job Description

Position: Health Program Specialist I (full-time)

Reports to: Director or Health Initiatives

Responsibilities:

- Develop and oversee the Health Initiatives (HI) databases, including internal and ETO databases
- Enter data into ETO and Excel databases for HI programs
- Monitor the accuracy of data entered into HI databases, including cleaning and coding of data
- Create a data entry system, distribute data assignments to the Data Specialist and HI team and ensure the accuracy of data entered
- Prepare Health Initiatives mid-year report, annual report, HI one pager, dashboard report and other reports as assigned by the Director of Health Initiatives
- Develop and oversee HI measurement, outcomes and evaluation of HI programs and projects
- Provide administrative coordination and onsite support for the Healthy Food Pantry Project and Blood Pressure Initiative
- Participate in the development of new and existing, projects, including conducting research, writing up of program pilots, and drafting protocols and procedures, as identified by the Director of Health Initiatives
- Stay abreast of national best practices and evidence-based research for new health initiatives
- Participate in the research and write-up of future grant opportunities
- Manage HI grants and prepare HI grant reports for mid-year and annual grant cycles
- Participate in the planning and implementation of health events across FC properties
- Prepare communications with other FC departments regarding Healthy Food Pantry Project and other initiatives
- Drive Health Initiatives cargo van to and from Central Texas Food Bank to FC food pantries
- Communicate needed van maintenance, operations, mileage log, refueling, repairs
- Attend health partnership meetings, seminars and conferences as identified by Director of Health Initiatives

- Maintain strong communication with the Director of Health Initiatives and HI team members, keeping HI Director included in all electronic communications with other FC departments and outside agencies
- Maintain a positive work environment and strive to build HI team collaboration
- Other duties as assigned by Director of Health Initiatives

Position Requirements

- Bachelors in Public Health, Social Work, Statistics or related field; Masters preferred
- Proficient in Excel
- Familiar with database management software
- Strong organizational skills
- Strong skills in research and evaluation
- Ability to manage multiple tasks and responsibilities
- Attention to detail, precision in data entry
- Ability to work independently and remotely
- Ability to drive a 15-seater, cargo van (training provided)
- Valid Driver's License and current Motor Vehicle Record (with no DUI's or critical at-fault accidents or moving violations within the last 5 years)
- Ability to lift 15-25 lbs
- Reliable and accountable
- Strong work ethic
