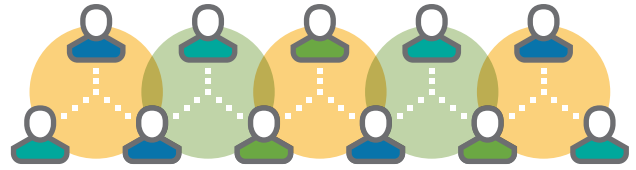


2022 PROSPER CENTERS **IMPACT REPORT**

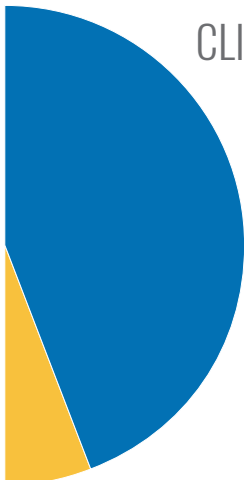

CLIENT ANNUAL INCOME

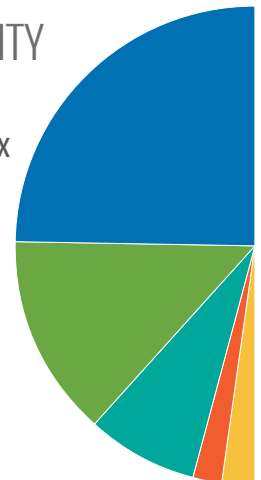


Average Annual Income: \$28,112

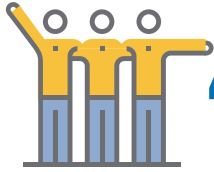

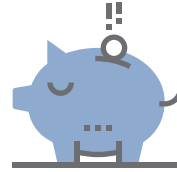


HEALTH CARE

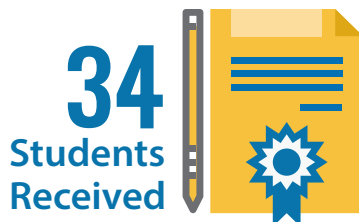
